## LEAVING A BEQUEST

#### **Unrestricted Gifts**

An Unrestricted Gift to Symbiosis International is the most favorable form of bequest as it allows us to use your donation in the areas of most need. An example is provided below.

#### LEAVING A BEQUEST

#### **Designated Gifts**

A Designated Gift is when you specify how you would like Symbiosis International to use your contribution. We will make every effort to respect your wishes, however in the event that its original purpose becomes inappropriate as situations change over the years, a provision in your Will permitting Symbiosis International to redirect the funds is most useful. For example:

I declare that the receipt of the Treasurer or other proper officer for the time being of the said company shall be sufficient discharge to my Executor for the said bequest.

### LEAVING A BEQUEST

#### **Residuary Gifts**

A Residuary Gift provides for Symbiosis International to receive whatever is left of your estate after specific bequests have been fulfilled. For example:

I give to Symbiosis International, 53 Prospect Road, Gaythorne, Queensland, 4051 all the residual and remainder of my estate (after payment of funeral and testamentary expenses and any duties payable on the estate before the residue is determined) to be used in such manner as its Board determines. I declare that the receipt of the Treasurer or other proper officer for the time being of the said company shall be sufficient discharge to my Executor for the said bequest.
